#### 43) To consider planning applications received from the Local Authority

#### DM/20/1645 The Manor House North Lane West Hoathly

Fell 1x Cherry (T1)

The committee had no comments but asked that MSDC are satisfied that a specimen tree is not lost from the street scene.

#### DM/20/1748 Cobwebbs North Lane West Hoathly

Yew(T1) – Fell

The committee had no comments but asked that MSDC are satisfied that a specimen tree is not lost from the street scene.

#### DM/20/1725 4 Weavers Cottages Church Hill West Hoathly

Leylandii – Remove

The committee had no objections.

#### DM/20/0696 Land Adjacent To 1 Hoathly Hill West Hoathly

Variation of conditions nos 1 of application DM/17/5074, to replace approved plans allowing for changes in design (Amended plans received 09.06.2020)

The committee has no objections to the variation but noted the comments from neighbours regarding the loss of hedging. The committee would endorse these comments as policy WHP2 of the West Hoathly Neighbourhood Plan requires development proposals to demonstrate that they will preserve the historic and rural character of the parish's historic lanes which includes Highbrook Lane.

#### DM/20/1878 Vine Yard Cottage North Lane West Hoathly

North, East and South, two storey extensions and roof alterations to accommodate first floor bedrooms, with first floor dormer windows to the North and South Elevations.

The committee felt it was unable to object but was disappointed to see that having received permission for a smaller extension another application has been immediately submitted to further increase the size of the property.

#### DM/20/1893 Long Meadow Station Road Sharpthorne

Variation to condition 2 relating to planning application DM/19/4538 to allow alterations to the approved design

The Planning Committee object to the proposed application. The original planning application for 4-5 bedroomed properties was amended to reduce the size of the dwellings to 3 bedrooms. This application seeks to increase the size back to 4 bedrooms which is against the West Hoathly Neighbourhood Plan and the need for smaller dwellings suited to the needs of an aging population, first time buyers and young families.

An increase in the size of the properties is likely to lead to a need for further parking spaces which are not available on site.

There was also concern that additional height above the garage may cause issues with overlooking of neighbouring properties.

## DM/20/1922 Pavilion West Hoathly Recreation Ground North Lane West Hoathly

Replacement Sports and Community Pavilion.

The committee had no objections.

#### DM/20/1833 The Conservatory Duckyls Selsfield Road West Hoathly

Demolish the existing dwelling and construct a replacement three bedroom, single storey dwelling with associated landscaping.
