Proposed outdoor natural swimming pool and garden pavilion within the grounds of Old House Barn. Minor alterations to the north elevation of Old House Barn to form two sets of doors for garden access (reduced scheme from previously approved ref. DM/17/5224)

Change of use of four existing farm buildings to an events venue. Small lean-to extension to the northern side of the main barn

The committee had no objections. The committee would expect that all the recommendations in the ecology report would be carried out in particular those regarding the owls and the bats.

#### DM/20/2987 Marjac Top Road Sharpthorne

Erection of three 4 bedroom dwellings with three carports.

The committee strongly object.

The proposed 4 bedroomed properties are against policy WHP7 (Infill Housing) in the Neighbourhood Plan which would except development within the built up area of 2 or 3 bedroomed houses suitable for young families or older residents.

Also with a bedroom in the roof space this is likely to cause greater overlooking over neighbouring properties.

The committee asked the clerk to write to the District Councillors asking them to consider calling the application in to the MSDC Planning committee if it is likely to be approved by delegated decision.

#### DM/20/3124 Lower Hammingden, Hammingden Lane, Highbrook.

Changing an area of agricultural land into garden. This is an application to establish whether the development is lawful.
